• In July, Gov. Wolf signed Act 57 of 2022 amending the local tax collection law which requires districts to waive the penalty, fee, interest, and other charges when new homeowners do not receive a bill notice within the first year of owning a property. Waivers need to be applied for through DCED and homeowners need to show proof of property transfer and attest that they did not receive a notice. District needs to adopt a resolution within 90 days of the effective date of October 11, 2022. This resolution will be on our agenda on or before January 7, 2023 for approval.
